Course: Eight lane, outdoor, 50 meter, heated pool, semi-automatic start & timing. A warm down pool is available. The competition course has been certified in accordance with 104.2.2(C). The minimum water depth, measured in accordance with Article 103.2.3, is 13 feet, 0 inches at the start end and 4 feet, 0 inches at the turn end.

Eligibility:

1. Open to any USA swimming athlete holding a current USA Swimming registration card as of the meet entry deadline. Proof of registration must be presented to the Clerk of Course if requested. On-deck registration will not be available at any Arizona Swimming meet.
2. All athletes must be under the supervision of a USA Swimming member coach during warm-up, competition and warm-down.
3. All athletes must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. Please notify the meet director of any necessary arrangements regarding eligibility rule number 2 or 3 prior to the start of the first session of competition.
4. Age on **July 16, 2011** will govern for this meet.
5. All coaches and officials must be USA Swimming registered prior to the competition and shall wear their current USA Swimming registration in a visible manner. Registration will be checked at the Clerk of Course prior to the start of each session.
6. Swimmers with a disability are welcome to enter this meet. The coach or entry chairperson must alert the Meet Director as to the need for any special accommodations or seeding arrangements.

Rules:

1. The current USA Swimming rules of competitive swimming will govern.
2. Athletes are limited to five (5) individual events per day.
3. Entry times must be swimmers' best **long course** times.
4. All events are pre-seeded, timed final events. All events are NTS.
4. The Arizona Controlled Meet Warm-up and Safety Guidelines will be posted and enforced.
5. Time trials may be offered at the discretion of the meet referee.

Entries: Email entries to robynferro@gmail.com. All entries must be submitted in Hy-tek format. Meet entries are due Sunday, July 10, 2011 by midnight.

Entry fees are due by the start of the first session, Saturday, July 16, 2011. Payment may be made by cash, check or credit card. Make checks payable to **YMCA Westside Silver Fins**.

Awards: Ribbons will be awarded for 1st through 8th place in 8 & under events.

Hotels: There are a number of great hotels in the vicinity of the pool.

Concessions: A full snack bar with candy, snacks, meals and beverages will be open during each session of the meet.

Vendor: Ski Pro will be on site during the Saturday and Sunday sessions for all of your swim equipment needs.

Parking: Parking availability at the Southwest Valley Family YMCA is restricted. We ask that all officials, coaches and volunteers park in adjacent lot to the YMCA (main parking lot). There will be a drop off/ pick up area located near the community entrance of the pool for anyone that is not a coach, official or volunteer.
All parents and swimmers must use church parking lot to the east of the YMCA. Please enter the church parking lot using the driveway immediately east of the YMCA parking lot entrance on Thomas. Please do not use the parking lot located on the North-West corner of the YMCA. It is for the city of Goodyear skate park only.

Results: Results will be posted on the YMCA Westside Silver Fins website (www.wsfins.com) after the conclusion of the meet. Results will be available as a downloadable zip file for Team Manager as well as PDF format for immediate viewing.
